Alternative service delivery model

COMBINED SHIFT PROPOSAL

Current backshift working pattern :

6 out of 7days, Monday to Saturday. Hours of work - Monday to Wednesday 1500-1900, Thursday 1500 -1930, Friday 1430 - 1900 and Saturday 1130 -1900.

Proposed combined shift working pattern:-

5 out of 7 days, working 2 weekends out of 3. Appendix 1 details the pattern and hours of work.

To deliver the service by the proposed combined shift working pattern the existing number of (backshift) posts will increase from 10 to 15 posts – 2 Operative 6 posts, 2 Operative 5 posts, 6 Operative 4 posts, 5 Operative 3 posts.

The 5 vacant posts will be :-

Operative 6 – 1 post

Operative 5 – 1 post

Operative 4 – 2 posts

Operative 3 – 1 post

Earnings - the change in working pattern results in an increase in contractual earnings for existing backshift employees.

This change removes the current requirement to cover the service by voluntary overtime at weekends.

How the 5 new combined shift posts will be filled:-

There are currently 8 temporary employees employed in Streetscene, six of which work Monday to Friday.

Six temporary Street sweepers grade 3, 5 of which have driving licences will be asked to express a preference between – Operative 4 combined shift (2 vacant posts); Operative 4 Monday –Friday (Four Operative 4 posts require to be filled in Streetscene on a permanent basis.). All temporary employees will also have the opportunity to apply for the Operative 5 and Operative 6 posts, combined shift.

One temporary Street Sweeper grade 3 (non driver) will be matched into an Operative 3 post, (Combined Shift).

The remaining three combined shift posts will be advertised.

Where more than one employee expresses an interest in a post interviews will be arranged.

JOB DESCRIPTIONS

It is proposed the revised job descriptions are implemented.

Existing employees will be match into a post at the same grade with the following exceptions:

18 Street sweepers, Grade 3 currently acting up to Driver (non HGV) will be matched into permanent Operative 4 Grade 4 posts.

1 Footbridge attendant ,currently acting up as Driver (non HGV) Grade 4 will be matched into an Operative 4 Grade 4 post.

2 Drivers (non HGV) Grade 4 currently acting up to mechanical sweeper driver (compact) grade 5 will be matched into Operative 5 grade 5 post (one post holder works in back shift and shall form part of combined shift).

5 Team Sweeping Charge hands Grade 5, of which 3 have driving licences, those with driving licences will have the opportunity to apply for Operative 6 grade 6 (RRT Chargehand,2 posts), apply for Operative 5 grade 5 (RRT,2 Posts). Alternatively match into Operative 4 grade 4 post.

2 non drivers will have the opportunity to apply for Operative 5 grade 5 (RRT x 2 posts, job description outlines driving licence essential however an exception may be made in this case, any new employees would require to hold a full driving licence) or apply for Operative 4 grade 4 (Cemeteries post), alternatively match into Operative 3 grade 3.

Leisure management –

10 Leisure attendants Grade 2 will match into an Operative 3 grade 3 post.

7 Leisure attendants grade 2 who currently undertake a high level of driving on a daily basis (as street scene drivers) shall match into an Operative 4 grade 4 post.

2 Leisure change hands Grade 4 will be matched into Operative 6 posts (RRT) Training and support shall be given to staff ensuring they have the necessary skills to undertake the full range of duties.

TEMPORARY EMPLOYEES

Grounds maintenance

Ex Apprentices and temporary grounds maintenance staff, currently filling permanent posts on the structure, will be offered permanent contracts. There are currently 11 Grounds maintenance temporary staff 7 of which are ex apprentices grade 6, 2 are Arborists grade 6 and 2 are Grounds maintenance Operatives grade 5. See appendix 2.

Street Scene

Temporary employees within the current backshift group (2 staff) will be offered permanent posts however the proposed change of working arrangements will replace the current working times and pay.

There are 6 temporary employees (in Grade 3 posts) currently working Monday to Friday in Streetscene

Six temporary Street sweepers grade 3, 5 of whom have driving licences will be asked to express a preference between – Operative 4 combined shift (2 vacant posts); Operative 4 Monday –Friday (Four Operative 4 posts require to be filled in Streetscene on a permanent basis.). All temporary employees will also have the opportunity to apply for the Operative 5 and Operative 6 posts, combined shift.

One temporary Street Sweeper grade 3 will be matched into an Operative 3 post. (Non driver.)
